At the last study session, the resident committee putting together events for the July 4th celebrations requested an event permit. The board also thanked those residents that have stepped up in the planning process. Between meetings, very little had changed. The committee was planning to forego the bounce houses and still planned for OSF Wrestling to hold the commode races on their own. Brett Harrison stated that he'd talked to Brian Obenland(not in attendance) and per Brett, Brian requested he be able to use his business driveway for customers outside the parade timeframe, but otherwise was not going to have a car show or need any space on S. Main St. for any activities. There was no discussion on any requests by the bank to have the exit of their parking lot open or allow customers using the ATM to exit on Finley St. Mayor Wright stated that Jamie Pasquale at the Vermilion County Conservation District approved the use of the rail trail property for parking as long there would be no vehicles driving or parking on the trail itself. There was no overhead layout of the downtown area showing the events and vendor locations, but Brett explained that the bags tournament would be on Scott St. between THE BOX and the Village Hall, food vendors would be on S. Main along with craft vendors, and he was checking with the Jeep club about a Jeep show on the S. Main north of THE BOX and Sunset Funeral. Brett confirmed that all vendors would be operating on their own electrical, water, gas, etc. and would be cleaning up their own areas. Brett last stated that he was arranging for the Porta Potties and would update the board at the next meeting.
